However we don't guarantee against hip or elbow dysplasia after a #1 year of age. For we can't control what undue stress adoptees can put on young Doberman puppies. Please take caution, talk to your veterinarian to provide the best care for Joints & Bones of growing pup nor do we guarantee breeding soundness or thyroid for these can be caused by not meeting up to nutritional needs and other reasons. Doberman puppy is not guaranteed against kennel cough, coccidiosis, worms ,parvo, distemper, giardia, and other viruses once they leave RMD.

INL_____ Please for the well being of your Doberman Puppy use extreme caution until fully vaccinated. Keep puppy at home and away from any outside pets for their safety. We advice you to quarantine puppy until 12 weeks of age. Speak to your Vet for best plan for protecting your Doberman puppy.

RMD does NOT pay for any veterinarian visits, fees, after the pup has left RMD care. If puppy is found to have a genetic condition that it is guaranteed against; (proof from licensed vet is required and must state the condition in report mailed to RMD) for re placement puppy/adult. Adoptee may keep puppy adult at breeder discretion. Adoptee will receive a puppy of same quality from a future litter for the cost of ear crop and veterinarian fee's and care that normally runs \$1800-\$2000 at breeders digression of cost if any. Buyer can bring/ send puppy back to us at their expense for a full replacement puppy of equal value when next litter is available @ breeders discretion. No money refunds will be given for any reason 3 business days _____. If you Adoptee needs to bring Doberman puppy back within the 72 hour period there are precautions at RMD must take for you to do so to ensure the safety of the other Animals at RMD. Adoptee must take puppy to veterinary hospital to

have health check and negative Parvo test, Influenza test, normal temperature. RMD does not give refund until our Veterinarian evaluates puppy health. Any expenses or loss RMD incurred will be withheld within reason INL _____

Doberman Puppy is guaranteed for #1 year of age against the following defects Kidney or Liver shunt, or unforeseen birth defects, Birth defects show up within a year. We recommend blood panel to be preformed at 1 year of age to ensure health Guarantee. INL _____

We Guarantee against DCM on RMD Dobermans for 5 years against developing DCM on non breeding dobermans, Heart echo must be done at 1 year of age and every 2 years until 5 years of age and have Veterinarian send results to RMD each time if client does not do so voids healthy heart Guarantee INL _____.

If Doberman should pass from sudden death Client must have a Necropsy/Autopsy done on said doberman for cause of death and have the report sent from Veterinarian to RMD with recorded microchip number of Doberman by vet. INL _____

Don't Spay and Neuter before the age of 2 years of age Voids all health Guarentee's. Please don't do so for well being of Doberman for they need there growth hormones to fully mature INL _____

If adoptee / buyer cannot keep this Doberman puppy for any reason, Adoptee MUST notify Breeder if they can no longer keep the puppy or dog, For breeder to make arrangement safe pick up or transport at adoptee expense by not doing so buyer/ adoptee will be held liable for all expenses and damages and legal fees. However we won't except Dobermans that is deemed dangerous INL_____

Adoptee/Buyer agrees to keep animal as a INSIDE PET ONLY and keep in the best health possible and have yearly exams. Buyer agrees to provide food, water & shelter if animal will be outside for any period of time. Dobermans must NOT be kept as an outside dog, sold for research/, sold to puppy stores/ brokers, or used solely for a guard dog.
